To be requested at time of reservation and paid by the customer on pick up:

Baby/Booster seat - NZ\$14.95 per day (maximum charge \$74.75 per rental)

Snow Chains - NZ\$14.38 per day (maximum charge \$115.04 per rental)

Ski Racks - NZ\$14.38 per day (maximum charge \$115.04 per rental, not available for the Intermediate Van)

GPS - NZ\$12.59 per day (maximum charge 10 days)

Snow Liability Cover - NZ\$8.05 per day (compulsory for vehicles traveling above the snow line)

Charges for additional products and services will be charged per hire and must be paid direct by the customer upon vehicle collection.

For your protection – Vehicle Liability (In North America a liability is referred to as the “deductible”).

All vehicles are insured for the damage to the vehicle or to the property of a Third Party. The hirer is responsible for the first **NZ\$345** (“the liability”) of the cost of damage including single vehicle accident (does not include Single Vehicle Rollover), towing and recovery costs, theft, fire, break-in or vandalism with the exception of the ‘exclusions’. This also includes the cost of the daily rental for the period the vehicle is off fleet for accident repairs.

The liability is applicable regardless of who is at fault and must be paid at the time the accident report is completed. The liability will be refunded if Maui is successful in recovering the cost of the damages from the Third Party (Third Party claims can take months to resolve). The liability applies in respect of each claim, not rental.

Vehicle Security Deposit

A vehicle security deposit is required on collection. For security purposes, only the hirers credit card can be used to provide a vehicle security deposit. The credit card holder is jointly and severally liable for any damage to the rental vehicle. The vehicle security deposit is **NZ\$150** and is taken as an imprint to the hirer's credit card and is not debited provided the vehicle is returned on time, to the correct location, undamaged, with a clean interior and with a full fuel tank.

IMPORTANT NOTES:

- In certain damage circumstances, the renter will be liable for the full damage costs of the vehicle regardless of liability cover

- Rental is responsible for ensuring the car is fueled with the correct fuel, vehicles could use either diesel or gasoline
- If the renter has their own insurance the Accident Damage Excess must be paid to Maui in the event of an accident. It is the renters responsibility to claim this charge back through their own insurance company
- A rental day is 24 consecutive hours, a grace period of 30 minutes applies. After this the renter is liable for an extra day hire and current applicable daily rate
- A credit card surcharge of **2.2%** currently applies on all credit card transactions processed by Maui
- This is not an exhaustive list of rental terms and conditions and possible charges. Details may change at any time. See Maui Rental Agreement for more details.

GENERAL DRIVING RESTRICTIONS

Vehicles can only be driven on sealed roads. Rental vehicles are not permitted to be driven on Skippers Road, the Road to Macetown, Tasman Valley Road and 90 Mile beach, plus other remote roads. Road restriction information is to be used as a guide only – check your rental agreement for full details of driving restrictions and it is recommended you check your intended itinerary at time of booking and rental collection.
